ADVANCED SECURITY FEATURES TO PREVENT UNAUTHORIZED ACCESS

Multi-Factor Authentication

CCR DirectAccess two-factor authentication requires the use of two of the three authentication factors as defined with the Homeland Security Presidential Directive 12 (HSPD-12).

RSA Token

CCR DirectAccess uses a software based RSA algorithm as part of its cryptosystem to provide end to end encryption.



HTTPS / Secure Socket Layer (SSL) Secure Web Interface

CCR DirectAccess is accessed using a web based interface, there is no software to install. We have added an additional layer of security by employing the Hyper Text Transfer Protocol Secure, commonly referred to as HTTPS, url scheme to provide an extra layer of encryption to facilitate secure communication over computer networks.

RSA 256 bit encryption

CCR DirectAccess was designed from the ground-up with security in mind. CCR DirectAccess employs the RSA 256 bit encryption to keep data secure. This is the same level of security used for financial transactions by some banks.
