### Reminders:

- CCR Volume 1 takes priority over the SEER manual whenever there are any differences in reportability or coding instructions.
  - **Do not** use the Solid Tumor Rules to determine reportability.

  - Summary Stage Manual
  - SEER\*RSA

  - EOD Manual
  - Grade Manual
